## III. Methodology

02/26/2026	Contact- Document received I received an application for special certification for developmental disabilities from licensee designee, Danielle Jones.
03/03/2026	Contact- Telephone call made I provided technical assistance with licensee designee regarding completing thorough intake assessments to ensure all residents are compatible with one another and I requested an updated admission policy and program statement.
03/03/2026	Contact- Document received I received, via email, the updated admission policy and program statement.
03/05/2026	I reviewed documentation provided and facility information in BITS.

## IV. Description of Findings and Conclusions

Based on the information received, the facility is approved to admit residents aged 18 and over who are mentally ill or developmentally disability. The facility is not approved to admit residents in wheelchairs.

The licensee designee, Danielle Jones, provided verification that she has over one year experience working with individuals who are developmentally disabled and mentally ill. She has worked for Radclift Inc, the owners of two other group homes serving mentally ill and developmentally disabled residents, since 2010. She has worked as a home manager and is currently the director of operations and finance. She is also employed as a section manager for the Michigan Public Health Institute. She has previous experience as a community health navigator, a senior clinical administrative coordinator, and a COVID-19 vulnerable population liaison and testing implementation manager. She is aware of the requirements of maintaining a special certification, as the other homes owned by Radclift Inc, also hold special certifications.

**V. Recommendation**

I recommend issuing a special certification for the developmentally disabled and mentally ill populations for Murrell House.
