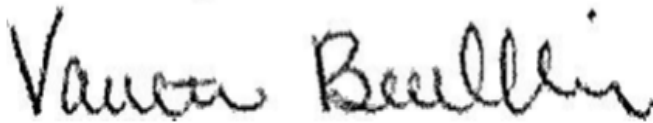

ALLEGATION: On 04/30/2026, Washtenaw County Environmental Health Department gave a D-rating to the sewer system at the Love & Care Services LLC adult foster care facility.

INVESTIGATION: On 06/01/2026, environmental health inspector, Catlin Handy, confirmed that she had conducted an environmental health inspection at the property of adult foster care facility, Love & Care Services LLC, on 04/30/2026. Ms. Handy stated based upon her findings, she gave the sewer system a D-rating and recommended the system be replaced. Ms. Handy stated her findings were discussed and explained to licensee designee, Lidia Ionita.

On 06/01/2026, I reviewed the Washtenaw County Health Department Report dated 04/30/2026. The following recommendation was stated, "This facility has been determined to be in substantial non-compliance with applicable rules. Approval is not recommended."

On 06/01/2026, I conducted an interview with licensee designee, Lidia Ionita. Ms. Ionita confirmed that on 04/30/2026, environmental health inspector, Catlin Handy, assessed the facility's sewer system and gave it a D-rating. Ms. Ionita stated she

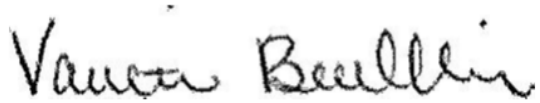
discussed the findings with Ms. Handy, who also gave her the recommendation that the sewer system be replaced. Ms. Ionita reported that she is in the process of obtaining a permit from her local zoning authority and once that is completed, she will search for a company to replace the sewer system.

On 06/01/2026, I conducted an exit interview with licensee designee, Lidia Ionita, and discussed my findings with her. Ms. Ionita agreed with my findings and stated she would submit a corrective action plan to address the violation found in this investigation.

APPLICABLE RULE	
R 400.645	Environmental health.
	(4) Sewage must be disposed of in a public sewer system. In the absence of a public sewer system, sewage must be managed and discharged of in a manner of on-site wastewater treatment that is approved by department of environment, Great Lakes, and energy in compliance with part 31 of the natural resources and environmental protection act, 1994 PA 451, MCL 324.3101 to 324.3134, or where applicable, the local health department.
ANALYSIS:	Based upon my investigation, which consisted of multiple interviews with environmental health inspector, Caitlin Handy, and licensee designee, Lidia Ionita, and a review of pertinent documentation relevant to this investigation, there is enough evidence to substantiate the allegation that the sewer system at the Love & Care Services LLC adult foster care facility was given a D-rating on 04/30/2026. Therefore, the sewage is not managed or discharged in a manner that is approved by the Washtenaw County Environmental Health Department.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon receipt and approval of a corrective action plan, I recommend no change in the status of the license.
