II. Purpose of Addendum

G&O Enterprise LLC is requesting to modify the license name change of facility from Parkview Residence to Crestwood East due to a broader rebranding, operational transition, strengthening the facilities identity and improving consistency in operations under current ownership.

III. Methodology

On 5/20/26, received an email from Jared Morrison G&O Enterprise LLC board of directors member. Jared Morrison reported he was requesting what steps and documents were needed for a facility name change. Jared Morrison was informed of the steps needed per AFC policy and provided copies of required documents that must be submitted.

On 6/8/26, I received and reviewed documentation from Jared Morrison that included updated program statement, DBA filing forms for facility name change, completed BCHS_5055 form and written explanation for name change.

IV. Description of Findings and Conclusions

Through a business sale agreement on 6/21/25 G&O Enterprise LLC purchased adult foster care facility Parkview Residence from Garth and Odette Hutton. G&O Enterprise LLC board of director members submitted a request appointing Miranda Moody as Licensee Designee and Krystin Walker as Administrator of Parkview Residence and approved on 6/23/25. On 6/8/26 G&O Enterprise LLC board of directors submitted required documentation requesting facility name change from Parkview Residence to Crestwood East. These changes will be made in BITS to reflect facility name on all licensing documentation for the following facility: AL130407342 Parkview Residence.

V. Recommendation

It is recommended facility name change on the above licensed facility of Parkview Residence changed to Crestwood East effective 7/1/26.

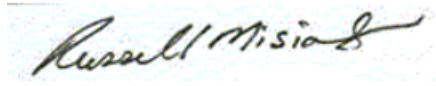
