II. Purpose of Addendum

Licensee Senait Hailu submitted a modification request on 7/27/2026 to add program types of Mentally Ill and Developmentally Disabled to the license and to lower the age to 18 years.

III. Methodology

On 7/23/2026, licensee Senait Hailu submitted documentation qualifying her to provide care to residents diagnosed with mentally ill or developmentally disabled.

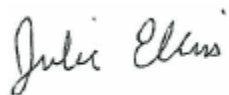
IV. Description of Findings and Conclusions

Based on the documentation and qualifications submitted, Senait Hailu meets the requirements to provide care to residents diagnosed as mentally ill and/or developmentally disabled. The administrator Simon Naygi does not meet these qualifications and therefore Senait Hailu has been appointed as administrator and requested that Simon Naygi be taken off on 7/28/2026. On 08/03/2026, Senait Hailu's clearance to be added as the administrator was processed by licensing departmental technician Brandi Kolasa.

Peace Adult Foster Care will serve individuals aged 18 and older with mental illness, developmental disabilities, and age-related needs. The facility's goal is to support residents in maintaining their highest level of functioning by keeping them active, engaged, independent, and comfortable. This will be achieved through a structured environment, individualized assessment plans with achievable goals, and well-trained, compassionate staff.

V. Recommendation

I recommend that Mentally Ill and Developmentally Disabled program types are added to the license for Peace Adult Foster Care and the aged of the resident be lowered to 18 years.
