ALLEGATION:

Staff gave Resident A double dosage of medication.

INVESTIGATION:

On 6/17/26, I conducted an interview with the complainant who verified the information.

On 6/18/26, I conducted an interview via telephone with direct care staff (DCS) Dasia Wiltse with recipient's rights advisor Sarah Watson present for the interview. DCS Wiltse stated they were giving Resident A her medication when she stated she guessed she was taking her medication again. DCS Wiltse stated once they heard the statement, she ran back in the house to check the medication administration records (MAR). DCS Wiltse stated it was the wrong day and verified the medication

was already given for that day. DCS Wiltse stated DCS Vanessa Epley was the medication verifier that day.

On 6/24/26, I conducted an interview with DCS Vanessa Epley via telephone and recipient's rights advisor Sarah Watson was present for the interviews. DCS Epley stated she was responsible for checking the MAR to verify DCS Dasia Wiltse gave the resident the medication correctly. DCS Epley stated Resident A told them she had already taken her medication as she was swallowing the second dosage. DCS Epley stated she went back and checked the MAR and realized they were on the wrong date. DCS Epley stated her and DCS Wiltse contacted the hospital and their management. DCS Epley stated Resident A was taken to the emergency room where she was released shortly after. DCS Epley stated staff followed protocol, but was on the wrong date for the MAR.

On 6/24/26, I conducted an interview with DCS Jacqueline Armstrong via telephone. DCS Armstrong provided a statement consistent with those made by DCS Epley.

On 7/23/26, I conducted an unannounced investigation at the facility. I conducted an interview with assistant home manager Emily Hages. Ms. Hages provided a statement that was consistent with those made by DCS Epley. Ms. Hages stated all staff have been retrained on medication administration. Ms. Hages provided me with Resident A's hospital paperwork which confirmed her emergency room visit. Ms. Hages provided me with the critical incident report and the incident report, which was filled out by DCS Wiltse. The reports verified Resident A was given Atorvastatin 40mg, Calcium 600, Duloxetine 60mg, Januvia 100mg, Lisinopril 30mg, Metformin 1,00mg, Metoprolol succinate 50mg and Multivitamin tablet.

On 7/24/26, I conducted an interview with home manager Stephanie Kirby via telephone. Ms. Kirby stated DCS Epley and DCS Wiltse got a written discipline and retrained on medication administration. Ms. Kirby stated she spoke with all staff and advised them of the need for proper checking of dates with administering medication.

APPLICABLE RULE	
R 400.675	Resident medications.
	(1) Medication must be given, taken, or applied as prescribed, ordered, or directed by an appropriately licensed health care professional.

ANALYSIS:	Based on my investigation, interview with staff and the review of documents. There was corroborating evidence of the staff giving Resident A, double dosage of her medication.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon the approval of the corrective action plan. I recommend the status of the license to remain unchanged.

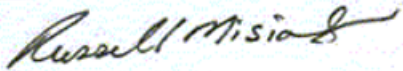
