The licensee decided to increase capacity, therefore changed an “office” bedroom into a bedroom again. The new bedroom is on the main floor, near the other two existing bedrooms and bathroom. The bedroom measures 10 feet, 7 inches by 8 feet, 9 inches, therefore having over 65 square feet of usable floor space for one bed. The bedroom is nicely decorated and carpeted, with a closet and window.

V. Recommendation

That the capacity of this Adult Family Home license be increased to 3.
