## **II. Purpose of Addendum**

In April m2003, the licensee requested an increase in licensed capacity from 3 to 5. The licensee was in the process of remodeling the lower level of the home (a walk-out) to include one bedroom for 2 residents.

## **III. Methodology**

The remodeling of the resident bedroom was inspected in May 2003 and again on December 11, 2003.

## **IV. Description of Findings and Conclusions**

The lower level bedroom has adequate square footage to accommodate 2 residents. The room has an approved egress window, and there is also an exit at ground level to the backyard. Furnishings are in compliance with rule requirements and smoke detectors are installed appropriately.

## **V. Recommendation**

I recommend approval of an increase in licensed capacity to 5 effective 12/11/03.
