II. Purpose of Addendum

The licensee requested the capacity of the facility be increased from four to five AFC residents.

III. Methodology

07/31/2006: This consultant met with the licensee at her facility and measured rooms.

IV. Description of Findings and Conclusions

Ms. Wynsma and her two minor children are the only non-AFC residents living at the facility. There used to be three minor children living with Ms. Wynsma but her now adult daughter has moved out. Ms. Wynsma would like to place an additional AFC resident in a bedroom that presently is occupied by only one AFC resident.

The bedroom in question is the only main floor bedroom that is not on an "end" of the facility. It has 152.45 square feet, which comes to 76.22 square feet per bed. Rule 400.1432(2) requires bedrooms to have not less than 65 square feet of usable floor space per bed.

Now that Ms. Wynsma adult daughter has moved out, the bedroom used by that daughter has been converted to living space. The facility new living space total is 577.9 square feet, which comes to 72.23 square feet per occupant (8 occupant total). Rule 400.1427(1) requires 35 or more square feet of living space, per occupant.

V. Recommendation

It is recommended the capacity of the facility be increased from four residents to five.
