II. Purpose of Addendum

The purpose of this addendum is to modify the recommendation to a provisional license to allow time to make the correction as required by the Bureau of Fire Safety as it relates to Rule 400.15403 (1).

IV. Description of Findings and Conclusions

On 2/16/06, The Bureau of Construction Codes – Fire Safety (BCCFS) issued a “C” rating for this facility because this facility failed to comply with installing a smoke detector in the dining room, as required in a fire safety report dated 11/9/05. On 3/31/06, BCCFS issued a “D” rating, meaning “Disapproval,” based on their return inspection on this same date when they observed continuing non-compliance. On 4/11/2006, BCCFS issued a “C” rating until 5/11/2006 because the Licensee Designee submitted an acceptable Corrective Action Plan. However, as of 7/12/2006, the required smoke detector yet has not been installed and the temporary Fire Safety approval time has expired. Fire Safety Officer 1 indicated he felt the facility was given ample opportunity and time to make the correction since the initial citation was made November of 2005. Fire Safety Officer 1 indicated he would return to the facility for a recheck when the facility notifies him that the correction has been made.

On 7/12/2006, Brian Wissink indicated the required smoke detector has not been installed, but the intent of Bridges Crisis Center is to comply with Rule 400.15403 (1) regarding the installation of the this smoke detector. Brian Wissink indicated the problem has been getting an approval from the appropriate source to install the smoke detector. Brian Wissink indicated he felt the department has been generous in the time that was allowed to comply with installing the smoke detector. This remains the only administrative rule violation stemming from Special Investigation 2006A0565030. Brian Wissink submitted an acceptable Corrective Action Plan that was approved on 6/12/06, which allows the department to issue a six-month provisional license. When the project is completed, please notify this consultant immediately.

APPLICABLE RULE	
R 400.14403	Maintenance of premises.
	(1) A home shall be constructed, arranged, and maintained to provide adequately for the health, safety, and well-being of occupants.
ANALYSIS:	The facility had received a "Disapproval" from the Office of Fire Safety for failing to comply with installing a smoke detector in the dining room, as required by the fire safety report dated 11/9/2005 and 2/16/2006. A "C" rating was since issued, but the correction remains to be completed.
CONCLUSION:	VIOLATION ESTABLISHED

V. Recommendation

It is recommended that a provisional license be issued.
