12/19/2006 – Contact Telephone Call Made, Confirmed divorce of licensees


01/12/2006 - Inspection Completed On-site

**IV. Description of Findings and Conclusions**

On 12/19/2006, this consultant received a letter signed by Mr. Jere Dehring. The letter was dated 012/01/2006. In the letter Mr. Dehring requested that his name be removed from the Dehring AFC Family Home license, as he no longer lived there. During a telephone call to the facility on 12/19/2006 and again during an on-site inspection on 01/12/2006, this consultant confirmed with Ms. Paula Dehring that she and Mr. Jere Dehring were divorced, and he no longer resided at the facility. As part of the divorce decree Ms. Dehring retained the adult foster care home. Mr. Dehring agreed to move out of the home and to give up all interest in the Adult Foster Care home.

**V. Recommendation**

It is recommended that Mr. Jere Dehring's name be removed from the license per his written request of 12/01/2006.
