Anne Bueche has had two licensed specialized homes that serve adults with mental illness for over ten years. Anne Bueche reported that she has completed the "Trainer of Trainers" class and is a Group Home training instructor for Ionia Community Mental Health. Anne Bueche also forwarded copies of all her training to the Office of Children and Adult Licensing to verify that she qualifies to be an Administrator. Ms. Bueche completes Recipient Rights training and Behavioral Management training annually. Anne Bueche meets the one year requirement of experience serving adults with mental illness and has completed training for that population.

V. Recommendation

It is recommended that the population served be enhanced to include serving adults with mental illness effective immediately.
