## III. Methodology

On March 28, 2007, this licensing consultant received an appropriately signed Request For Modification Of The Terms Of The License.

On March 28, 2007, this licensing consultant reviewed Anne, Bueche, Designated Licensee and Administrator, experience.

## IV. Description of Findings and Conclusions

Anne Bueche, Designated Licensee, has had more than twenty years of experience working with developmentally disabled, mentally ill, and physically handicapped populations. Anne Beuche has also taught several community mental health group home classes through Ionia County Community Mental Health.

(Developmentally disabled and mentally ill populations were inadvertently added to the license when issuing special certification on July 28, 2006, without originally being licensed to serve these populations.)

## V. Recommendation

I recommend that developmentally disabled, mentally ill, and physically handicapped populations be added to the regular license.
