II. Purpose of Addendum

The purpose of this Addendum to the Original Licensing Study Report is to officially change use of space at Kathy's Countryside AFC Home.

III. Methodology

On March 2, 2007, this licensing consultant received Request For Modification Of The Terms Of The License for changing use of space.

On March 30, 2007, this licensing consultant inspected the changes of use of space at Kathy's Countryside AFC Home.

On March 30, 2007, floor plans and emergency evacuation plans were reviewed.

IV. Description of Findings and Conclusions

On March 30, 2007, this licensing consultant inspected an addition to Kathy's Countryside AFC Home. The four person multi-occupancy bedroom was remodeled for use as a semi-private bedroom. Two private bedrooms were built-on the north end of the home. The dining room was enlarged and is currently a combination dining and living room. A new resident bathroom was constructed.

On March 30, 2007, this licensing consultant measured the multi-occupancy bedroom that was converted semi-private bedroom. This bedroom contained 172.5 square feet of space. This bedroom contained a window and was protected by a battery operated smoke alarm. Door hardware was of the non-locking-against-egress type.

On March 30, 2007, this licensing consultant measured the two private bedrooms that were recently added on the north end of the physical plant. These private bedrooms each contained 96.37 square feet of space. These private bedrooms contained a window and were protected by battery operated smoke alarms. Door hardware in each private bedroom was of the non-locking-against-egress type.

On March 30, 2007, this licensing consultant measured the living room addition. The living room added an additional 171 square feet of common space earmarked for resident use.

On March 30, 2007, this licensing consultant inspected the newly constructed resident bathroom. This bathroom met the requirements for bathrooms as specified in the Licensing Rules for Adult Foster Care Family Homes.

On March 30, 2007, this licensing consultant reviewed a revised floor plan and plan

for emergency evacuation. The emergency evacuation plan was prominently posted in the home.

V. Recommendation

I recommend that the Department approve the proposed changes in use of space at Kathy's Countryside AFC Home as identified in this report.
