## **IV. Description of Findings and Conclusions**

Robert Fulton, Licensee Designee, has operated four adult foster care homes in Tuscola County, Michigan for five years. Mr. Fulton has served the mentally ill population in three of his four homes, for five years. Mr. Fulton has operated Circle Drive Home since September 17, 2002. Mr. Fulton has the required experience to provide care to the mentally ill population.

## **V. Recommendation**

I recommend adding mental illness to the license as an additional population being served at the Circle Drive Home.
