II. Purpose of Addendum

The purpose of the addendum is to increase the capacity of Vadavilla AFC Home from 14 residents to 15 residents.

III. Methodology

July 11, 2007 – On-site inspection of the facility.
August 13, 2007 – Request to increase capacity received from Licensee.

IV. Description of Findings and Conclusions

The home has always been approved for 14 bedrooms, 13 single rooms plus a double occupancy bedroom. The previous licensee of the home occupied one of these bedrooms and thus the home was only licensed for 14 residents. The current licensee does not live in the facility and will now utilize this bedroom for resident use. The home is in compliance with all applicable Adult Foster Care, Environmental Health and Fire Safety rules.

V. Recommendation

It is recommended that Vadavilla AFC Home increase its capacity to 15 residents.
