## II. Purpose of Addendum

The purpose of this addendum is to add services to persons with developmental disabilities to the license and special certification of the Saginaw Meadows Adult Foster Care home.

## III. Methodology

November 26, 2007 – Letter received from Jamie Bragg-Lovejoy requesting that DD population be added to the license of Saginaw Meadows. A new program statement was developed for this home supporting this population.

## IV. Description of Findings and Conclusions

A revision to the Saginaw Meadows AFC home program statement including those with developmental disabilities into the population serviced by this home was requested on November 26, 2007. This consultant reviewed the program statement and found the revised program statement to be in compliance with all applicable licensing rules and statutes.

## V. Recommendation

It is recommended that persons with developmental disabilities be added to the license and special certification for the Saginaw Meadows AFC home effective immediately.
