Mr. and Mrs. Clark have added a double occupancy bedroom. This bedroom measures 11' 6" x 12'6", or 144 sq. ft., adequate for double occupancy. The bedroom is appropriately furnished.

There is adequate general living space available as required per R 400.1427(1) in the existing features of the home.

V. Recommendation

To increase capacity of this adult foster care home from 2 (two) to 4 (four) residents in need of adult foster care services.
