**II. Purpose of Addendum**

A request was received from the licensee designee to reduce the capacity of the home from eleven residents to nine residents

**III. Methodology**

April 17,1997 Original application received  
January 9, 1998 Original license issued capacity eleven.  
January 9 to present Operated as a licensed adult foster care facility capacity eleven.  
July 8, 2008 request received to reduce the capacity from eleven residents to nine residents. Capacity reduced.

**IV. Description of Findings and Conclusions**

An on-site inspection was completed on July 8, 2008 for the purpose of renewing the license. At that time Mrs. Waack requested that the capacity be reduced from eleven to nine residents.  
Bedroom four and bedroom five were semi-private. Mrs. Waack removed one bed from bedroom four and one bed from bedroom five. The capacity is one resident in bedroom four and bedroom five.  
Total capacity for the home has been reduced from eleven residents to nine residents.

**V. Recommendation**

I recommend the capacity of the license be reduced from eleven residents to nine residents.
