The living room directly off the foyer is now a resident bedroom measuring 201 square feet. The new bedroom has 2 beds and meets licensing requirements for 2 residents.


The upstairs northeast resident bedroom is now a staff bedroom.

The total square feet of living space 267 sq. ft. that includes the family room (160 sq. ft.) and dining room (107 sq. ft.).

Ms. Majsambaji construction change was inspected and approved by the city of Lansing on November 18, 2008.

I recommend the capacity of the license be increased to 6 residents.
