II. Purpose of Addendum

An application was received from the authorized representative on 3/10/08 requesting modification of the original license to increase the licensed capacity from 56 to 60 beds. Plans for the new construction were approved 4/25/08 to add a new beauty shop and media center in addition to the four additional beds.

III. Methodology

An on-site inspection of the completed renovation and new construction was completed on 9/10/08. The addition to the existing home added four additional beds increasing the capacity from 56 to 60.

IV. Description of Findings and Conclusions

Approval for the addition and increase in bed capacity to 60 beds was received from MCDH, Health Services Engineering Section, on October 20, 2008.

Approval for the addition was also received by DLEG, Bureau of Fire Services, on April 25, 2008.

V. Recommendation

It is recommended the home for the aged license of Christian Haven Home be increased to 60 beds.
