**II. Purpose of Addendum**

On 3/13/2009, the Department of Human Services Bureau of Children and Adult Licensing received a letter from Kathleen Swantek Authorized Representative for Sanborn Gratiot Memorial Home. The letter dated 3/12/2009 requests that the street address for Sanborn Gratiot Memorial Home be changed from 2732 Cherry Street to 2735 Gratiot Avenue. The facility has not moved, but rather changed the location of the entrance from facing one street to another.

### III. Methodology


On 2/09/2009, this Licensing Staff conducted a renewal licensing inspection at Sanborn Gratiot Memorial Home. At that time, one wing of the facility was under construction of an addition that would alter the location of the entrance to the facility. The Administrator, Melinda Priehs, explained that the home would in effect be facing a different street. Request for plan reviews of FS project #381781 and HFES project #20080194 were submitted by Ms. Swantek. Permit for construction of this addition has since been approved by the Department of Labor and Economic Growth Bureau of Fire Services on 2/23/2009 and by the Department of Community Health - Health Facilities Engineering Section on 2/23/2009.

### IV. Description of Findings and Conclusions

Sanborn Gratiot Memorial Home license number AH740236889 has had an addition constructed to one wing of the building. The addition changed the location of the facility's entrance. The entrance no longer faces Cherry Street but instead faces Gratiot Avenue. A change of street address has been requested by Authorized Representative, Ms. Swantek, changing the address from 2732 Cherry Street to 2735 Gratiot Avenue Port Huron, MI 48060. This change in address is approved by the Department of Human Services Bureau of Children and Adult Licensing.

### V. Recommendation

It is recommended that the facility's license be modified to change the street address from 2732 Cherry Street to 2735 Gratiot Avenue Port Huron, MI 48060.
