II. Purpose of Addendum

On January 26, 2009, the licensee submitted a written request to increase the capacity from 4 to 6. On June 10, 2009, the licensee amended his request to increase the capacity from 4 to 5.

III. Methodology

An onsite inspection was completed on 6/10/2009.

IV. Description of Findings and Conclusions

The proposed resident bedroom is located on the second floor, northeast corner. The bedroom contains 121 square feet of usable floor space. This is adequate for one resident. The facility contains 459 square feet of indoor living space. This exceeds the requirements for five occupants. The bedroom has the required furnishings.

V. Recommendation

I recommend that the capacity for this facility be increased from 4 to 5, effective immediately.
