III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Physical Description of Facility

Grand Pines Assisted Living Center is a one story, 85-bed barrier-free home for the aged located on a residential street in Grand Haven. There are 32 resident rooms in the facility designed for 2 beds and 21 resident rooms designed for 1 bed each. There is no smoking allowed inside of the facility, but there are designated smoking areas on the premises. A beauty salon is located within this home for the aged.

The facility includes a special care unit designed for individuals who have been diagnosed with Alzheimer's disease or a related condition. This special care unit is a secured area of the home containing 14 of the 53 resident rooms in the facility. Of these 14 resident rooms, two rooms are designed for two beds and the other 12 rooms contain one bed each. All exit doors of this special care unit are secured with key pads requiring a pass code. A private, secured outdoor garden area is available exclusively for the residents of this special care unit.

B. Program Description

Grand Pines Assisted Living Center is a home for the aged for adults age 60 years and older who require assistance with activities of daily living such as transferring, eating, dressing, bathing, and medication administration. Grand Pines Assisted Living Center also offers activities for socialization and exercise.

Grand Pines Assisted Living Center's special care unit is called The Terrace. This secure unit is specifically designed for residents with Alzheimer's Disease or other forms of dementia. I


Staff employed by Grand Pines Assisted Living Center are trained to perform the duties and responsibilities of their positions and are evaluated by the facility's administrator or designee prior to working independently with residents and periodically thereafter. Staff working in the secure unit receive additional training specific to provide service to residents who have been diagnosed with Alzheimer's or other forms of dementia.

C. Rule/Statutory Violations

The applicant is found to be in compliance with the licensing act and applicable administrative rules.

IV. RECOMMENDATION

I recommend issuance of a temporary license to this home for the aged.
