Licensee requested an increase from 1 resident to 2 residents.

III. Methodology

IV. Description of Findings and Conclusions

Kinkle's AFC is a tri-level home with a two car attached garage located in Holly, Michigan. The first level of the home has a large living room, a dining room, a large kitchen and sunroom. The upper level of the home has one full bath, three bedrooms, one is occupied by a resident, one is Mr. Kinkle's, and the third bedroom is vacant. The lower level contains laundry room, storage room, another bedroom, a large family room and the furnace room.


The home has a private water and sewage system. The Oakland County Health Department conducted an inspection on August 5, 2009 and received a "B" rating.

The resident's bedroom #1 measured at **11 x 11.5" = 125.6** square feet which was previously approved for one resident. Bedroom #2 which is currently vacant measures at **17.6 x 11 = 193.6** square feet which is approved for another resident.

The living room measured **17'10" x 18'1" = 322.3 square feet**. The dining room measures **11'11" x 10'10" = 129** square feet. The family room measures **16' x 25' = 400** square feet. The total living space equals **844.3** square feet for four occupants. This is more than adequate space for the licensee, his girlfriend and two residents.

V. Recommendation

I recommend an increase in capacity from (1) one male resident to (2) two male residents, Developmentally Delayed, 18 years and older for Kinkle AFC located at 11130 Fish Lake Rd., Holly, MI.
