Licensees requested to increase their homes capacity by licensing another bedroom in the home for resident use.

IV. Description of Findings and Conclusions

Licensees have an extra bedroom on the main floor that they want to use for adult foster care residents.

The bedroom contains over 143 square feet, which is adequate for 2 residents. The bedroom is located in the hall near the resident’s bathroom. The home has adequate living space to accommodate the increase in capacity.

The home now has 1 bedroom for single occupancy and 1 bedroom for double occupancy approved for resident use.

V. Recommendation

It is recommended that the licensed capacity for this adult foster care family home be increased from 1 to 3 residents effective 12/02/09.
