On-site inspection conducted on 07/09/2010.


IV. Description of Findings and Conclusions

Each resident room measured as follows:
Room #205- 19'9" x 16'= 312 square feet
Room #202- 19'9" x 16'= 312 square feet

Each room has ample space for two residents and each room has the necessary furnishings for each resident.

I recommend that the change of use space is approved for Resident Rooms #202 and #205 to be used as semi-private rather than private rooms.
