II. Purpose of Addendum

A change of use space was requested by the licensee regarding the location of resident bedrooms. This would not increase or decrease the number of licensed beds in the facility.

III. Methodology

A scheduled on-site inspection was conducted at the facility on July 15, 2010 in response to the request.

IV. Description of Findings and Conclusions

The original licensing study report for this facility approved two resident bedrooms on the 1st floor and 1 double occupancy bedroom on the 2nd floor. The licensee requested removal of the 2nd floor bedroom for resident use, and the addition of 2 additional bedrooms on the 1st floor. The two additional bedrooms were remodeled from part of the original dining area and back porch. They are now located and measure as follows:

West Bedroom:	6'4" X 10'5" = 66 sq. feet	1 Resident
Southwest Corner Bedroom:	7'6" X 11'2" = 84 sq. feet	1 Resident

V. Recommendation

A change of use space is approved for the addition of two resident bedrooms for the 1st floor of the facility.
