II. Purpose of Addendum

The purpose of this addendum is to change the use of space enabling the use of two additional private bedrooms.

III. Methodology

On November 17, 2010, Bureau of Fire Services approval of the addition of two bedrooms was reviewed.

On November 30, 2010, a Request For Modification Of The Terms Of The License and revised floor plan was reviewed.

On December 1, 2010, an onsite inspection occurred. The two additional private bedrooms were inspected and measurements were verified.

IV. Description of Findings and Conclusions

The Bureau of Fire Services provided final approval of the addition of two private bedrooms on November 17, 2010. These private bedrooms are located on the Northeast and Southeast end of the facility. The Northeast bedroom contains 199.88 square feet of space and the Southeast private bedroom contains 151.74 square feet of space. Each of these private bedrooms contains a large half-bathroom. Each bedroom was appropriately furnished. These bedrooms are also included on the Emergency Evacuation Plan and revised Floor Plan. This facility currently contains fourteen (14) private bedrooms and three (3) semi-private bedrooms.

V. Recommendation

I recommend the change of use of space enabling the use of two additional private bedrooms without increasing the existing capacity of twenty (20) residents.
