II. Purpose of Addendum

Licensee requested an increase in capacity after receiving a variance approval related to usable floor space in bedrooms.

III. Methodology

11/03/2010 – Variance request submitted
12/07/2010 – Variance request approved by Division Director
02/04/2011 – Onsite inspection completed

IV. Description of Findings and Conclusions

Bedroom # 4 was 10 square feet short of compliance with the rule related to usable floor space in bedrooms. The Licensee requested a variance to Rule 400.14409 (3) by demonstrating that 2 residents could comfortably use this room. Division Director approved a variance that will allow 2 residents to use this bedroom under the condition that the bedroom may not be used by residents who use a walker or wheelchair. Should a resident who uses a walker or wheelchair be placed in this bedroom it must revert to a single person bedroom.

The licensee has agreed to the conditions of the variance.

The facility now contains 2 2-person bedrooms and 2 single person bedrooms. The facility has adequate living space to accommodate the increase in capacity.

V. Recommendation

It is recommended that the licensed capacity of this adult foster care small group home be increased from 5 to 6 residents effective 02/25/11.
