## IV. Description of Findings and Conclusions

The resident bedroom, bedroom #3, measures 17'2" x 10'5" which equates to 179 square feet. This is sufficient room for two additional residents. The bedroom also has all of the required furnishings for two residents. The living area space utilized by residents is 282 square feet which is also sufficient living space for six residents.

## V. Recommendation

I recommend that the license capacity increase from four residents to six residents.
