II. Purpose of Addendum

To increase the bed capacity of Park Village Pines from 160 to 190.

III. Methodology

On August 15, 2011, an opening survey was conducted by the Bureau of Health Systems at the Park Village Pines. This project involved the construction of an addition to house 30 newly licensed Home for the Aged beds, additional day/dining area, a new laundry, serving kitchen and staff space. With the addition, the facility will operate 190 licensed Home for the Aged beds.

IV. Description of Findings and Conclusions

The Bureau of Fire Services granted final approval of this project on August 18, 2011. The Bureau of Health Facilities granted approval of the license increase on August 26, 2011.

V. Recommendation

I recommend an increase of the licensed capacity of the Park Village Pines from 160 beds to 190 beds.
