II. Purpose of Addendum

Increase in the capacity of Brenda’s Little Acres adult foster care home, from 11 to 12 resident beds.

III. Methodology

On 01/24/2012, I received a written request from licensee Brenda Cantor, to increase the capacity of the facility.

On 01/26/2012, I conducted an onsite inspection and together with Brenda Cantor I inspected the facility including the room she wants to convert from the facility office to a resident bedroom.

IV. Description of Findings and Conclusions

Ms. Cantor has requested the facility office is moved to a common area of the facility. The bedroom was measured and determined to be 9 feet x 13.33 feet = 119.9 square feet. Sufficient capacity for one resident bed. The living space for the facility is 441 square feet. Sufficient living space for 12 residents.

V. Recommendation

I recommend the capacity for Brenda’s Little Acres, AM410293632, is increased from 11 to 12 resident beds.
