#### II. Purpose of Addendum

Teresa Myers submitted a written request on 2/14/2012 asking that that the terms of the license be changed from female only to both male and female and to decrease the capacity from six (6) to five (5).

### III. Methodology

### IV. Description of Findings and Conclusions

The facility currently has three double occupancy rooms. Teresa Myers would like to make one of these bedrooms single occupancy and leave the other two double occupancy. These three bedrooms met the square footage requirements for two residents during the original inspection therefore they have sufficient square footage for one resident.

With regards to changing from all female residents to both male and female, Teresa Meyers reports that she will have two females share a room and two males share another room and the single will be available for either a male or a female resident.

## V. Recommendation

I recommend that the terms of the license be changed to both female and male residents and the capacity of the facility be changed from six (6) residents to five (5).
