II. Purpose of Addendum

On 2/29/12, you requested an increase in licensed beds from 18 to 28. You requested that the "B" wing be licensed for ten beds bringing the licensed capacity to 28.

III. Methodology

I confirmed approvals from both Jeff McManus from the Health Facilities Engineering Section and Richard Day, the State Fire Marshal Inspector from the Bureau of Fire Services, to convert this unoccupied "B" wing to a ten bed home for the aged wing.

IV. Description of Findings and Conclusions

On 4/3/12, Mr. McManus recommended licensure of the ten private rooms in the B" wing for Home for the Aged use provided that minor physical plant items as listed in his 2/15/12 inspection report are completed. These included:

- 1. Occupancy approval from BFS
- 2. Repair/install flooring/shoebase, night lights, TV cover plates, and electrical convenience receptacles in sleeping rooms.
- 3. Replace/install missing light lenses, door handles, towel bar, and seal wall at sink penetrations in adjoining toilet rooms.
- 4. Provide beds, and nightstands.

Mr. Richard Day, the State Fire Marshal Inspector, approved this "B" wing for Home for the Aged use on 2/08/12. Also, the home has provided multiple pictures of this "B" wing hallway and bedrooms showing that all of the required physical plant issues have been corrected. This "B" wing contains ten private bedrooms, a dining room and a lounge.

It is recommended that the "B" wing of the Harbors Health Facility be included in the
