II. Purpose of Addendum

On 10/11/2011, a modification request was received asking to increase the capacity of the facility from two to three residents after the garage was converted into a hallway and bedroom.

III. Methodology

On-site inspections were completed on 01/27/2012 and again on 02/23/2012.

IV. Description of Findings and Conclusions


A second on-site inspection was completed on 02/23/2012 after violations that were found during the 01/27/2012 on-site inspection were corrected. Final building approval regarding the addition was received on 01/16/2012 from the Ionia County Building Department.

The proposed resident bedroom, Bedroom #3, measured 124.54 square feet which is more than adequate for one resident. The bedroom was fully furnished with the required bedroom furniture. The living area measured 240 square feet which is more than adequate space for three residents. The converted space not only added an additional bedroom and hallway, but also a storage room and a small mechanical room which houses the electrical panel.

A new floor plan and evacuation plan were also submitted and approved by this consultant.

V. Recommendation

I recommend that the capacity of the license be increased from two to three residents.
