II. Purpose of Addendum

To document the management agreement between Henry Ford Inc. and Life Care Services. In addition, to document the facility name change from Henry Ford Village, Inc. to Henry Ford Village Assisted Living Facility.

III. Methodology

On April 17, 2012, the Bureau of Children and Adult Licensing received notice of a change in management for Henry Ford Village, Inc. from the facility's authorized representative, Leslie Shanlian. Effective November 1, 2010, Henry Ford Village Inc. is now managed by Life Care Services LLC. The management agreement was reviewed by area manager Betsy Montgomery.

A business entity search of the Department of Licensing and Regulatory Affairs website was conducted.

On May 7, 2012, correspondence was received from Ms. Shanlian requesting a facility name change from Henry Ford Village Inc. to Henry Ford Village Assisted Living Facility.


IV. Description of Findings and Conclusions

A review of the Department of Licensing and Regulatory Affairs' business entity search revealed valid registration of Henry Ford Village Inc. and of Life Care Services LLC.

Henry Ford Village Inc. remains legally responsible for the home for the aged care at the facility, now known as Henry Ford Village Assisted Living Facility.

V. Recommendation

It is recommended that the current status of the license remain unchanged and that the name of the facility be changed to Henry Ford Village Assisted Living Facility.
