II. Purpose of Addendum

A modification request was received on 3/20/2012 to modify the terms of the license to reflect a wheelchair accessible facility

A request was also made to increase the capacity from five residents to six residents.

III. Methodology

IV. Description of Findings and Conclusions

The facility has wheelchair ramps located at both the main entrance/exit and the secondary entrance/exit which are both in compliance with licensing rules. The residents' bathroom and bedroom doors are 36 inches wide and are able to accommodate a resident using a wheelchair.

A room previously used as an office was changed into a bedroom in order to accommodate an one additional resident. The bedroom was adequately furnished and met licensing requirements. The bedroom measured 9 '8" x 13' 4" for a total of 131.32 square feet.

V. Recommendation

I recommend the terms of the license be changed to indicate that this facility is wheelchair accessible.

I also recommend that the capacity for this AFC facility be increased to six residents.
