**II. Purpose of Addendum**

Kathleen Swantek, the facility’s authorized representative, requested that the facility’s address be changed from 2735 Gratiot Avenue to 2732 Cherry Street, Port Huron, MI 49060.

**III. Methodology**

4/16/12 Contact – Document received. The post office returned as undeliverable a letter I mailed to the facility at 2735 Gratiot Avenue, Port Huron, MI 49060.

4/16/12 Contact – Telephone call made to Kathleen Swantek regarding undeliverable mail. Ms. Swantek will request address change for the facility.

4/19/12 Contact – Document received. 4/17/12 letter from Ms. Swantek requesting address change.

**IV. Description of Findings and Conclusions**

The facility has one entrance on Cherry Street and one entrance on Gratiot Avenue. Most people enter the building at the Cherry Street entrance. The post office will not deliver mail to both the 2732 Cherry Street and the 2735 Gratiot Avenue addresses for the building. Kathleen Swantek stated that the residents receive mail at the Cherry Street address, so Ms. Swantek preferred that be the license address for the facility. The Cherry Street address was the facility’s address since 1957, according to the oldest document in the licensing file, until Ms. Swantek requested on 3/13/09 that the Gratiot Avenue address be used after remodeling was completed to add a new living room and entrance on the Gratiot Avenue side of the building. The facility has not moved, but rather changed the side of the building where they desire mail to be delivered.

**V. Recommendation**

Change facility address from 2735 Gratiot Avenue to 2732 Cherry Street, Port Huron, MI 48060.
