**IV. Description of Findings and Conclusions**

On 05/30/2012 Renewal inspection completed on Mill Creek Home adult foster care home. Facility found in compliance with all applicable rules and statutes.

Living space measured at 16 X 16.2 = 259 sq. ft.  
Bedroom #1 measured at 11.9 X 12.4 = 147 sq. ft.

Mill Creek Home adult foster care home has enough living and bedroom space to accommodate 5 residents.

**V. Recommendation**

I recommend an increase of capacity of the Mill Creek Home adult foster care home from 4 to 5 residents.
