II. Purpose of Addendum

Modification of license-increase capacity from five to six residents

III. Methodology

June 7, 2012-Request for modification received

July 10, 2012-Inspection completed on-site

IV. Description of Findings and Conclusions

This facility has been licensed to Aina Acres AFC LLC since April 5, 2010 with a capacity of five. This home has had one private bedroom, and two double occupancy bedrooms.

The licensee designee Mr. Aina now proposes turning a room previously used for an office into a private bedroom. The dimensions are 12 ft by 9 feet, which provides 108 square feet, sufficient for a single occupancy bedroom. The room has a closet, bed, dresser, chair and mirror. The door hardware is non-locking-against egress.


Medications were previously kept locked in the closet. Mr. Aina has moved medications to an alternate locked cupboard elsewhere in the house.

Residents in the double occupancy room share a connecting full bathroom. A second bathroom is located in the hallway and will be available to both private room residents. The house has a third bathroom located in Mr. Aina’s master bedroom suite, so is not available for resident use.

This facility has sufficient living area to accommodate six residents and Mr. Aina.

V. Recommendation

I recommend increasing the license capacity to six residents.
