III. Methodology

11/27/2012 The licensee requested a change in the licensed capacity.

IV. Description of Findings and Conclusions

In the original licensing study the licensee requested a licensed capacity for 5 however the south bedroom was in non-compliance with licensing rule 400.14409 (3) A multi-occupancy resident bedroom shall have not less than 65 square feet of usable floor space per bed. Therefore the home’s licensed capacity was authorized for 4.

The licensee made the following modification to the south bedroom. The licensee removed an 11’9’ X 3’ closet and added a wardrobe. The south bedroom measurements are currently 11’9” X 12’. This bedroom is 141 square feet and can accommodate 2 residents.

V. Recommendation

I recommend the capacity be increased to 5.
