# IV. Description of Findings and Conclusions

Amy Sloan, Licensee Designee, renovated the former main floor office into a resident bedroom. The office has been moved to the basement level of the home. The new bedroom is located on the west side of the house, off the living room. It is 9' 4" X 9'7" for a total of 89 square feet of living space. The bedroom does not have a closet, but a wardrobe has been placed in the bedroom. The wardrobe takes up 6.5 square feet of living space, leaving the bedroom a total of 82.5 of usable living space in the bedroom, which meets the rule requirement. The home's living room has 239 square feet, which is enough to accommodate the increase in capacity.

The bedroom is fully furnished and meets all other licensing requirements.

# V. Recommendation

It is recommended that the capacity of Liberty House be increased from 5 to residents effective 02/15/2013. This effective date will coincide with the renewal of the license
