II. Purpose of Addendum

The purpose of this addendum is to document the licensee's request to increase the capacity of the facility from 4 to 6 residents.

III. Methodology

On January 15, 2013, the licensee submitted a *Request for Modification of the Terms of the License*. The request was a change of capacity to 6 instead of 4.

On January 15, 2013, I conducted an on-site inspection and measured the bedroom to be licensed. Bedroom #4 measured 11' 10" X 11' 10" for a total of 140 square feet. This is ample room for two residents.

The living space of the facility measured 21' X 12' for a total of 252 square feet. This meets the requirement of 35 square feet for six residents.

Bedroom #1 which was licensed for 2 residents will now be licensed for 1 resident.

The living room and sitting room measured 456 square feet. This is ample room for 6 residents, 4 adults, and 2 children living in the facility.

IV. Description of Findings and Conclusions

The change in capacity reflects the number of residents that can be served in this facility.

V. Recommendation

I recommend the capacity of this home be increased to 6 residents.


