II. Purpose of Addendum

The purpose of this addendum is to document the licensees' request to increase the capacity of the facility from 2 to 3 residents, and to add the population mentally ill to the license.

III. Methodology

On August 6, the licensee submitted a *Request for Modification of the Terms of the License*. The request was to increase the capacity from 2 to 3 residents and to add the population mentally ill to the license.

IV. Description of Findings and Conclusions

On August 6, 2013, the south bedroom, which is currently licensed for 1 resident, was measured. The bedroom measured 12'6" X 14'6" for a total of 181.25 square feet. This is ample room for 2 residents.

The licensee's credentials were reviewed and meet the requirements to provide care for the mentally ill population.

V. Recommendation

I recommend that the capacity of this home be increased to 3 residents and the population of persons diagnosed with mental illness be added to this license.
