#### II. Purpose of Addendum

The purpose of this addendum is to describe the addition the licensee has built onto his facility. The addition will increase the facility's capacity from sixteen (16) to twenty (20) residents.

## IV. Description of Findings and Conclusions

This facility has built a large addition on to the rear of the facility. The addition was built directly off the dining area and consists of a large walk-in shower room, small common area, furnace room, laundry room and four (4) private resident bedrooms.

The size of each new resident bedroom is 158 square feet. Each bedroom has its' own attached half bath and large closet. Every bedroom has its' own heating zone and can be heated or cooled separately from the rest of the facility.

The addition has its' own furnace and hot water heater. The heat plant/furnace room is located off the common area and is separated from the residents by an adequate firs door, equipped with an automatic self-closing device.

On 8/12/13, the addition was inspected by the Bureau of Fire Safety and was given an "A" rating.

# V. Recommendation

I recommend that the total capacity of this licensed facility increase from sixteen (16) to twenty (20) residents.
