II. Purpose of Addendum

III. Methodology


According to Ms. Marchica’s letter, the licensee CLP Sun III Tenant, LP changed its name to HCRI Sun III Tenant, LP effective July 1, 2013. The letter also states these are name changes only, the legal entities and their tax identification numbers have not changed. Also, according to a voice mail message from Ms. Marchica on September 12, 2013, the licensee address should be changed from 7902 Westpark Dr. McLean, VA 22012 to 7900 West Park Dr. Suite T-900, McLean, VA 22012.

IV. Description of Findings and Conclusions

Verification with the Michigan Department of Energy, Labor and Economic Growth Corporation Division Business Services website revealed a certificate of change filed on August 8, 2013, from CLP Sun III Tenant Limited Partnership to HCRI Sun III Tenant Limited Partnership, to register and transact business in Michigan.

V. Recommendation

It is recommended that the name and address of the licensee for this facility is amended from CLP Sun III Tenant Limited Partnership 7902 Westpark Dr. McLean, VA 22012, to the new name and address HCRI Sun III Tenant Limited Partnership 7900 West Park Dr. Suite T-900, McLean, VA 22012.
