II. Purpose of Addendum

The purpose of the Addendum to the Original Licensing Study is to change the use of space and to increase the capacity from five to six residents.

III. Methodology

On October 30, 2013, I received a written request from Marilyn Wilke, licensee, to change the capacity from five to six residents.

On October 30, 2013, I conducted an onsite inspection. I inspected and measured the northwest bedroom and sitting room addition.

IV. Description of Findings and Conclusions

On October 30, 2013, I reviewed a written request signed by Marilyn Wilke, licensee, to increase the number of beds by one bed in the northwest bedroom and to increase the capacity of the home from five to six residents.


On October 30, 2013, I inspected and measured the northwest bedroom. This bedroom was equipped with a window, smoke detector, non-locking-against-egress door hardware, and adequate furnishings. This bedroom measured 10' x 12' 6" or 125 square feet of space.

On October 30, 2013, I reviewed an approved exemption dated April 26, 1999, from Rule 400.1432 (2) allowing two residents to occupy this bedroom.

On October 30, 2013, I inspected and measured the sitting room addition. It has an attached porch with railings and handrails. It has a window, an interior door leading to the main part of the house, another door equipped with non-locking-against-egress door hardware leading directly to the outside, and an approved smoke detector. It measured 16' 7" x 11' and 8' 11" x 4' 7".

V. Recommendation

I recommend the change in use of space and capacity increase from five to six residents.
