III. Methodology


09/25/2013- On-site inspection completed and interview with Laura Rathbun.

Mrs. Rathbun would like to add the aged program to her license in order to provide care to individuals aged 55 years and over. Mrs. Rathbun plans to provide care to aged individuals with minimal physical care needs and only the beginning signs of dementia. Mrs. Rathbun does not plan to provide care to individuals who are diagnosed with Alzheimer’s Disease, wander or who have a history of aggressive behavior. Mrs. Rathbun would like to remove the physically handicapped program from the license as well.

V. Recommendation

I recommend that the addition of the aged program be approved and the removal of the physically handicapped be approved as well.
