II. Purpose of Addendum

The purpose of this addendum is to document the licensing of a 20 bed memory care program in the Story Point home for the aged.

III. Methodology

On 8/26/2013, the 40 bed Story Point home for the aged was licensed as a general home for the aged.

On10/30/2013, the authorized representative, Christina Pahl, requested that half of the home for the aged building be converted to a memory care program, rendering 20 beds to the general aged population and 20 beds to the memory care program.

An on-site inspection of the North half of the building, the new memory care program, was conducted on 11/5/2013.

On 11/8/2013, an acceptable memory care program statement was provided that complies with all items required by statute.

IV. Description of Findings and Conclusions

The Story Point home is a licensed Home for the Aged (HFA) providing services to a maximum of 40 seniors over the age of 60 years. The memory care program is licensed to serve a maximum of 20 residents with a diagnosis of Alzheimer's dementia or a related condition.

The home uses a program called "Moments in Time" which promotes creating and sharing positive experiences with the residents, families, friends and care-givers through activity based programs and daily interactions.

At the time of the person's admission to the program, a written assessment will be completed to ensure the program is able to meet the needs of the individual. Assisted and supervised personal care will be available to include but not limited to; assistance with grooming, meal time support, toileting, bathing, dressing, transferring, escort services, medication management, appointment coordination in addition to social and personal support.

The Activity Department provides a monthly calendar of events designed to promote activities which allow residents to function at their highest potential by promoting individual choice and embracing the uniqueness of each individual through recognition of their life experiences. The programming goal is 2-4 planned activities daily, with many unplanned activities throughout the day.

All employees will be educated through the Alzheimer's Association classroom training program during initial training to include; Foundations of Dementia Care and Training in Critical Areas to meet the needs of the residents. Staff is trained using a

combination of MALA approved curriculum, Alzheimer's Association Dementia Training, and Story Point specific policies and procedures. Continuing education will be presented through staff meetings and in house in-services and training on an ongoing basis (minimally monthly).

The physical environment within the memory care program is designed to provide the least restrictive environment while ensuring safety for the residents. The community is secured with an alarmed delayed egress system with key pad and card access at each door exiting out of the memory care area. All doors are locked, from the outside, 24/7 with key pad entry. For the residents' safety, there is a lock on each window which stops the window from opening more than three to four inches. A secure and enclosed courtyard is attached to the end of the memory care hallway, allowing residents to be able to go outdoors without risk of wandering away.

V. Recommendation
