**II. Purpose of Addendum**

Ruth Hanna, Licensee, added an addition to the existing adult foster care family home. While the licensed capacity remains unchanged, the home now can offer 2 private rooms to residents.

**III. Methodology**

01/22/2014 – On-site inspection conducted as part of the license renewal inspection.

**IV. Description of Findings and Conclusions**

A bedroom and bathroom were added on the southwest side of the home. The changes did not affect other areas of the home. The bedroom is 14' x 9'6", which equals 133 square feet of usable floor space. The bedroom is for single occupancy and the bedroom adjoining the new bathroom will also be for single occupancy. There is a battery operated smoke detector in the bedroom.

As there is no change in capacity all other information remains the same.

**V. Recommendation**

It is recommended that the new bathroom and bedroom be approved for resident use.
